Dear Exhibitor & Potential Exhibitors,

This is the nineteenth annual Art-on-the-Rocks fine art and craft show and sale. The show is located at the southern tip of Maxwell/Whalen Island (at the Gillespie's). This location has worked well, as it is not susceptible to the west wind and we've found that a fair number of cruisers and Sunday afternoon boaters on the main channel stop in to browse and shop. We are initiating new advertising this year. We provide a free shuttle/jitney service to larger boats that anchor in the bay. This service is for customers and vendors.

Maxwell Island, often referred to as Whalen's Island, is located on the Muskoka Landing Channel (inside main channel). It is about 10 kilometers north of Honey Harbour. In previous shows, artists and crafters have displayed a wide variety of artwork including paintings, pottery, photography, stained glass, woodwork, jewelry and culinary arts. We encourage artworks that are inspired by the unique Georgian Bay landscape. The event is well attended by Cognashene and Honey Harbour cottagers, their friends and neighbours from surrounding communities. This is your invitation to participate in **Art on the Rocks 2010 !!**

In an effort to keep the show interesting and exciting, we are always looking for new artists and crafters. Please feel free to share this form with any friends you have who do high quality crafts or art, especially if they employ an outdoor or Georgian Bay theme. We ask new artists (or unknown to coordinators) to please submit photos or slides of their work. ## Conditions of Entry:

1. There is a \$35 entry fee, \$65 if you require transportation by boat to and from Honey Harbour. A cheque should be included with your application made payable to the **Cognashene Cottagers Association**. This is a non-profit event. Each individual exhibitor is expected to pay all fees including transportation; 1-2 helpers are included in taxi transport.
2. There are two indoor spaces, with electricity, located in the boat shed. There is an additional \$15 surcharge for these spaces. They will be assigned on a first request basis. Other spaces may also be assigned.
3. Exhibitors are asked to bring a sign identifying you by name and/or company name.
4. Transportation, insurance of your work and liability are your responsibility.
5. If you use glass as part of your work, please be advised that the rocky terrain can be dangerous to your work if it is dropped.
6. Materials and methods for displaying your work are your responsibility. Display areas are approximately 10'x10', but are irregular in shape and terrain. Because of that, minimal display equipment is needed. The terrain can serve as a beautiful display. There is no need to transport extra items. Coordinators have final OK on location of exhibition. Very few artists use "tents" as they are difficult to set up on the rocks.
7. Sales and taxes are to be managed by you.
8. This is a Rain, Wind or Shine event. Exhibitors are responsible for providing your own shelter from the elements. Hopefully, the weather will be more cooperative than in 2009~the ONLY really bad weather day.
