Boat License Workshop for Kids aged 8 - 18

I found an instructor who conducts safe boating workshops for kids. At the end of the workshop, kids take the exam for the Pleasure Craft Operator Card. They will receive their card immediately after achieving 75% or higher. The workshop covers all material required for the exam, with a special emphasis on the kind of boating that we do in Georgian Bay. Kids can try the exam more than once if they don't pass the first time, for no extra charge.

Here are some of the details I'm working on:

- -Sunday, July 8th, 11 2pm (to be confirmed)
- -Location to be determined in our cottage community
- -\$70 75 (to be confirmed), includes exam fee and workshop fee
- -Minimum age to attend: kids born in 2004

The instructor is from the National Boating Safety School, which is one of the oldest boating schools approved by Transport Canada.

The Georgian Bay Land Trust (GBLT) continues to be a leader in land protection and stewardship on the eastern shore of Georgian Bay and the North Channel

There is a new GBLT property in your area! We are delighted to announce the closing of the Kemerer Easement on Bone Island in Cognashene. Adjacent to two other easement lots, Kemerer contributes to the protection of one of the highest priority areas of the southern half of eastern Georgian Bay. Kemerer's forest-interior wetland complex provides confirmed breeding habitat for eastern fox snake and songbirds, while its coastal meadow marsh supports several regional and provincially significant plant species.

Throughout the past two decades, the GBLT has been working on expanding its land conservation abilities through our fantastic group of volunteer stewards and now the formation of Neighbourhood Committees, one of which has been established in the Cognashene area. We are currently looking for Cognashene locals interested in land protection who would like to help the GBLT identify opportunities for protecting and acquiring land in the

Municipal Affairs

Ward Boundary Review:

There is still no date set for the public meeting regarding the Ward Boundary Review. The outside consultant has completed his work and supplied the township with numerous options from which to choose. The cottage associations are still weighing in with their recommendations and it is expected that a public meeting will be announced for some time this summer.

Official Plan Review:

The rewrite of the OP is far behind schedule. A draft of the Plan was supposed to be available to the public on February 6th. Due to a family emergency, the original consultant who handled the public meetings has been replaced and the township planning employees have become involved in writing the draft. There has also been a hand-over of responsibilities for the Planning Department. The new Manager is Jill Lewis who has been working as a senior planner for the Township of Orillia.

Open Space:

A public meeting held on May 5th was well-attended and demonstrated strong support for the Ad Hoc Committee's recommendations. What is being proposed is a wording that clarifies the intent of the current by-law wording. It does not permit any structures on undeveloped Open Space islands. The wording will come before Council for adoption sometime this summer. Eventually, when the Official Plan gets rewritten, the zone will be

renamed from "Open Space" to "Natural Space" to convey the intent more expressively.

Correction:

In the last Newsletter, the Municipal Affairs Report stated that a particular planning application was "supported by the planners". This should have read "tacitly supported by the planners".

The Planning Department no longer makes recommendations in their planning reports. This means that the planners do not directly support or reject any planning application. However, there have been many examples whereby "tacit" support has been provided. These could be such things as ignoring Federal, Provincial or District policies and requirements, overlooking variances, accepting surveys that do not show the high water mark, omitting details about the deficiencies of a particular application and the implications, misdirection of the neighbours/community, and accepting incomplete and/or inaccurate applications.

GBA Activities April 2011 to March 2012

Fisheries Committee

- Petitioned the MNR to stop Asian Carp, continue to support EGBSC, curtail gill net fishing, toughen rules for large scale fishing tournaments.
- Petitioned MNR and MOE for the elimination of open cage aquaculture and worked with them as they
 developed new guidelines for same.
- Met with the Chair of the Federal Parliamentary Committee reviewing aquaculture practices in Canada.
- Consulted with WWF Fresh Water Trout Dialogue as they set standards for the certification of farmed trout.
- Worked with EGBSC to support their Walleye restoration
- Published UPDATE articles on Asian Carp, Walleye restoration, alternate aquaculture technologies.
- Worked with Environmental Commissioner of Ontario re aquaculture resulting in his making recommendations on aquaculture.

Lands and Forests Committee

- Filed EBR submission regarding commercial wind development and the Natural Heritage Assessment Guide.
- Petitioned MNR and MOE for curtailment of the environmentally damaging motor cycling and ATV racing at the Ontario Camp for the Deaf.
- Petitioned the MNR, MOE and Ministry of Energy to review the Green Energy Act to close the loop hole that enables the installation of large ground mounted solar arrays without any community involvement or municipal oversights
- Monitored and reported on White Nose Syndrome that is killing our resident bat population. (UPDATE Vol. 21 No. 3)
- Researched and published UPDATE articles on invasive plant Phragmities, bat killing Whiten Nose Syndrome, MNR's Crown Land Use Policy, Cougars, Invasive Species, electricity rates and energy reduction strategies.

Water Committee

- Represented GBA on the Advisory Panel to the Canadian negotiators of the Great Lakes Water Quality
 Agreement (GLWQA), the South Georgian Bay Lake Simcoe Source Water Protection Committee and Public
 Interest Advisory Board for the International Upper Great Lakes Study Board (IUGLSB).
- Facilitated meetings with the IUGLSB, GBF, Sierra Club, Great Lakes United, Lake St, Clair landowners to discuss water levels
- Presented GBA concerns and suggestions to Minister Bradley (Ontario MOE) who re Great Lakes Protection Act.
- Published UPDATE articles on the GLWQA, Source Water Protection, botulism, International Joint Commission's Biennial Conference.
- Petitioned the MNR to permit the use of Phoslock in Sturgeon Bay in order to address on ongoing Blue Green Algae issue.
- Met with York Region and reviewed their plans for waste water treatment in the Lake Simcoe (Georgian Bay)
 watershed.
- Met with the Township of Georgian Bay, and water testing organizations including GBF to discuss water testing protocols for coastal Georgian Bay. (UPDATE Vol. 21 No. 3)

Boating and Safety Committee

- Participated as a member of the National Recreational Boating Advisory Council and the Ontario Recreational Boating Advisory Council.
- Briefed Minister Clement on our issue of excessive boat
- Published UPDATE articles on Shipping on the Great Lakes, OPP Boating Safety, boat noise
- Continued to dialogue with OPP re issues brought forward by our members.

Government Affairs Committee

- Held meetings with Tony Clement, Norm Miller, Linda Jeffery (MNR), Jim Bradley (MOE), Ontario Environmental Commissioner and senior staff at MNR, MOE and Environment Canada at which we presented a range of issues that we are working on (see detailed issues above).
- Met with Townships of Archipelago, Carling and Georgian Bay to review GBA activities.
- Met with representatives of Wikwemikong First Nation and Ministry of Aboriginal Affairs to discuss areas of common interest.
